## REQUEST FOR INFORMATION – BIOREMEDIATION PRODUCTS

Johannesburg Water SOC Ltd.

### PREAMBLE

Johannesburg Water SOC Ltd (JW) is seeking *Request for Information* from consortia, joint venture and/or individual providers with proven products for the biological remediation of wastewater matrices (standing and flowing water, sediment, and soil). This document is intended to provide all the necessary information to enable providers to submit an expression of interest to meet the requirements.

### BACKGROUND

Johannesburg Water SOC Ltd (JW) is a municipal entity of the City of Johannesburg (CoJ) incorporated on 21 November 2000 and commenced business on 1 January. JW was formed following the iGoli 2002 Transformation Plan, an initiative led by the former Greater Johannesburg Metropolitan Council.

The entity supplies 1.6 billion litres of potable water per day, procured from Rand Water, through a water distribution network of 12 288 km, 127 reservoirs and water towers, and 37 water pump stations. The company employs 2 716 people and functions within six operating regions, with ten network depots and six wastewater treatment plants. Wastewater is collected and reticulated via 11 710 km of wastewater networks and 38 sewer pump stations. Johannesburg Water treats 926 ML per day of sewage at its six wastewater treatment works (WWTW).

### INTRODUCTION

Johannesburg Water (JW) with 11 710 km of networks and 38 sewer pump stations dedicated to wastewater collection frequently experiences interruptions in the system, leading to spill events in the networks and failures in pump stations resulting in overflows. This has a negative impact on the affected environment (water bodies, rivers, streams, ecological), where sewer spill management is required, which incorporates biological remediation of the affected areas.

Johannesburg Water (JW) is implementing a sewer spill management plan, encompassing various aspects of the value cycle. The primary aims being to protect the environment from dire negative impacts, timely response and recovery of the environment. This objective being to have response measures with a solution focus, where the affected space can be dealt soon after the onset of the spill event. Biological methods of dealing with spills is the preferred approach, due to many natural benefits, and as such bioremediation technologies are utilised for the treatment and removal of pollution and contamination.

### **OBJECTIVE OF THE REQUEST FOR INFORMATION**

This Request for Information is being initiated to solicit responses from all interested parties who house and produce biological materials that are primarily aimed at the treatment and removal of harmful contaminants in water matrices and sediment areas.

Interested parties are requested to submit information on their products with supplementary information and the costing, where JW thereafter purchase the products for field testing, bioremediation simulations. The bioremediation capability investigation of the products will be conducted as part of a collaboration study between JW and Council of Scientific and Industrial Research (CSIR).

Predetermined parameters will be used to evaluate the performance of the submitted products. It is envisaged that this evaluation will inform JW on the more appropriate and viable products for the use in sewer spill bioremediation processes.

## CERTIFICATE OF INDEPENDENT BID DETERMINATION

2. I understand that the accompanying bid will be disqualified if this Certificate is found not to be true and complete in every respect;
3. I am authorized by the bidder to sign this Certificate, and to submit the accompanying bid, on behalf of the bidder;
4. Each person whose signature appears on the accompanying bid has been authorized by the bidder to determine the terms of, and to sign, the bid, on behalf of the bidder;
5. For the purposes of this Certificate and the accompanying bid, I understand that the word "competitor" shall include any individual or organization, other than the bidder, whether or not affiliated with the bidder, who:
  - (a) Has been requested to submit a bid in response to this bid invitation;
  - (b) Could potentially submit a bid in response to this bid invitation, based on their qualifications, abilities or experience; and
  - (c) Provides the same goods and services as the bidder and/or is in the same line of business as the bidder
6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium<sup>3</sup> will not be construed as collusive bidding.

7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
  - (a) prices;
  - (b) geographical area where product or service will be rendered (market allocation)
  - (c) Methods, factors or formulas used to calculate prices;
  - (d) The intention or decision to submit or not to submit, a bid;
  - (e) The submission of a bid which does not meet the specifications and conditions of the bid; or
  - (f) Bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
